## 2024 Chapter Attendance Award

The Chapter Attendance Award was established to give recognition to chapters that each year reaches out to the greatest number of members within their chapter area. To make sure the large chapters do not dominate, the award goes to the chapter with the highest percentage of eligible credit unions within the chapter area to be consistently represented at the chapter's meetings over a twelve-month period from August through July.

The chapter selected will be recognized at the League's Annual Meeting banquet.

## AWARD CRITERIA

In determining attendance at chapter meetings, consider ONLY persons attending meetings who represent:

1. The main office or branch office of a Kentucky League-affiliated credit union located within the chapter's boundaries; and
2. The branch office of an out-of-state credit union located within the chapter's boundaries provided the credit union is a dues-paying member of the league in the state where the main office is located.

To enter your chapter in the Attendance Award competition:

1. Complete this Entry Form (attached) on your chapter's attendance figures from August 1, 2023 through June 30, 2024.
